Rangitāiki Community Board 2024 - 2034 Long Term Plan Submission

Rangitāiki Community Board (RCB)

are aware of the complexities of the Long

Term Plan (LTP), and the difficulties needing new capex and continuation of opex to maintain the levels of services we currently enjoy, and for new investments that are intended for the benefits of future generations.



We fully understand Whaktāne District Council (WDC) is currently experiencing a level of unprecedented inflationary pressures with their Consumer Price Index (CPI) drastically increasing for materials, such as concrete and bitumen.

We acknowledge the comms team for the time and effort in collating the LTP communications and resources. Community feedback to the resources provided consisted of:

- Too long, didn't read (TLDR)
- · Not to sure what some of the words meant
- Options given doesn't reflect what I want to say

We suggest providing opportunity for community/whanau input when developing resources and written material to provide insights and suggestions of formats that are easy to engage with, and language that is easy to understand across various platforms. This should include plain language that is both concise and direct.

We hope that our submission is able to provide a voice to guide Council's decision making process on the effects that our communities will experience.

1. Rangitāiki ward:

- a. We have had a large degree of feedback from our community that uses wheelchairs and mobility scooters regarding lack of disability parking around the ward, poor quality of footpaths and how this negatively impacts their quality of life.
- b. Roaming dogs and personnel security is a major concern and additional funding in this area is desirable. Extra staffing and body cameras for this would be desirable.
- c. Support with desexing costs has been raised by communities across Rangitāiki.
- d. Support for and resourcing a rural centres beautification scheme.
- e. We encourage WDC to adopt the Aotearoa Reorua initiative
 - Bilingual signage within in all communities
- f. Support and advocate for updating road signing with macrons / tohutō
- g. Continual investment of multimodal interconnectivity i.e. cycleways over the district between towns.
- h. Upgrade of existing toilet facilities across the district and appropriate locations with appropriate signage and mapping on services like Google Maps.
- i. Rangitāiki parks and reserves require shade sails, water fountains, BBQ areas, appropriate seating, disability access and access to public toilet facilities.
 - i. Edgecumbe skatepark (Shade & BBQ)
 - ii. Eivers Playground (BBQ) & support to build skate park
 - iii. Riverslea park (BBQ & half court basketball)

- iv. Okorero (Thornton) (Adventure park extension to current playground, pump track)
- v. Matatā Beachfront (BBQ)
- vi. Matatā playground (Water fountain/refill station)
- j. Support water safety education schemes in our rural communities Harbour board water safety fund may be able to be utilised for this.
- k. Standards for new stormwater grates to have fish or wetland species shown to remind persons that stormwater is untreated and disposed into our awa.
- l. Support the beautification of rural communities and townships to have an equitable lens that is comparable to those of our main townships.
- m. Supporting the extension of safer and appropriate speeds within our rural communities and townships.
- n. WDC continues to support community groups such as Lions, EDIT, BlueLight, etc.
- o. Supporting and capturing the history of our community areas by supporting those communities, such as via record access and funding.
- p. Reinvigorating existing historical stories of our local area of cultural significance.
- q. WDC continues to develop and support the partnership between iwi, hapū, and whanau. Including the recognition of the cultural relationships with waahi tapu, sites of significance including pā and urupā, whenua (including development), and our wai.
- r. Create a rural equivalent of EPIC / chamber of commerce for rural business / Rangitaiki Plains development and refocus on circular economies. Provide staff support for a Rangitaiki Plains Business Hub and resources. Including Matatā / Pikowai.
- s. Support for roading improvements around the Rangitaiki Plains.
- t. Development of strategic EV locations.
- u. Assess suitable freedom camping spots within Rangitāiki and surrounding Wards, including:
 - i. Edgecumbe domain (to include shower)
- v. Beachfront carpark reserves are maintained to acceptable standards for persons with disabilities to enjoy and use them.
- w. Environmental strategies and signage to align directly with TRONA environmental plan
- x. WDC continues to support RCB newsletter

2. Matatā priorities:

- a. Reticulated wastewater in Matatā.
- b. BBQ installation at the Matatā Domain.
- c. Maintenance of beach access and vegetation at Matata Domain.
- d. Awatarariki debris flow reserve development having something done with the space and beautification. Supporting the development in collaboration with iwi aspirations.
- e. Waimea Stream continued cleaning and maintenance.
- f. Speed reduction on Pakeha Street and pedestrian crossing installation, request WDC advocate and support this via Waka Kotahi.

3. Te Mahoe Priorities

- a. Security and maintanence/upkeep of Te Mahoe dam car park area.
- b. Advocate and support aspirations of Te Mahoe Village.
- c. Included in dam operations, monitoring, stats and decisions.

4. Te Teko priorities:

- a. WDC provides maintenance and beautification of the business area / town centre. This would include the footpaths and grass berms / parks and the quality of the spaces, and implementing maintenance plans for it, in a way that is equitably to the main townships in the Whakatāne District.
- b. The Te Teko / Mapou walkway is high traffic and frequented by the community. We support regular scheduled maintenance and upkeep.
- c. Safe speeds around our rural communities. E.g. extending 50km/h area in Te Teko
- d. Support submitting to Waka Kotahi for traffic calming measures, such as vehicle islands opposite the Post Office and Mapou Marae.
- e. Improve Dog control in Te Teko / Mapou.
- f. Te Teko bus area (road widening, maintenance and upkeep).

5. Edgecumbe priorities:

- a. Papataonga Reserve Stage 2 supporting the aspirations of affected families to pursue Stage 2 development.
- b. WDC to support the efforts of E.D.I.T, being the beautification team of Edgecumbe, continue to support the volunteer efforts in this space.
- c. Support beautification works, e.g. murals on telephone boxes
- d. That WDC continues to support extension of the youth council in small townships and access to halls or community facilities for youth initiatives and events (ie. Edgecumbe war memorial hall).
- e. Edgecumbe public toilets to upgrade existing toilet block on Kauri Street, and install better signage to guide non locals.
- f. Upgrade Edgecumbe Lions reading room with audio visual capabilities as this is the main meeting room for various community groups including RCB.
- g. Edgecumbe Library to have a paid full time member to increase hours and access to services using this space as a WDC hub for community to pay rates, dog registration etc. This provides access for our elderly and wheelchair bound community members.

6. Okorero/Thornton priorities:

- a. Lighting options for the upper car park area to light dark areas.
- b. Support aspirations for Tarawera and Rangitāiki restoration groups advocating for river water quality and mauri of our awa.
- c. Alongside iwi / hapū / community, assess / explore location and funding for a Cultural centre 'collective' building/hub at Okorero to support:
 - ★ Marine Biology / environmental science research (school and community)
 - ★ Surf life saving club (community)
 - ★ Waka ama (community)
 - ★ Cultural and Heritage centre Museum (Iwi, Community, School)
 - ★ Cafe / Restaurant (Community, School)
- d. Vegetation maintenance and beautification (i.e. Onehunga weed spray on grass areas, long grass areas either planted or maintained)
- e. Rope swing on wharf beside manu platform as previously planned.

7. Manawahe priorities:

- Support extending the sealed roading network and roading quality improvements (e.g. Herepuru Road)
- b. Support upgrades to the area in Manawahe which was subject to flooding.

Submission to Whakatane District Council- long term plan.

This submission relates to the Awakeri shopping area and car park – and the need to install a public toilet at this location.

My name is Paul Francis I am the director of AWAKERI RAIL ADVENTURES the rail tourist business that operates from Awakeri.

The shopping area at Awakeri urgently needs a public toilet to be installed.

I submit the following matters in support of the proposal.

1. Edgecumbe, Teneatua and Te Tekeo and Matata all have at least one public toilet in each town ship. Awakeri shopping area has none.

Traffic volumes (toilet users) through Awakeri are far higher in AWAKERI than that of the above mentioned town ships. This is due to the fact that there are 2 state highways that run through Awakeri.

- 2. There are more businesses in the Awakeri village than the other near by townships. Resulting in more people stopping to use toilets in Awakeri.
- 3. Awakeri rail adventures operates 7 days per week through most of the year. We have been in operation for 9 years.

The Railway tourist venture brings approximately 5 thousand visitors per annum into the district. I believe that we are now (with the sad loss of White island tours) the largest tourist operation in the district. Most of our customers are from out of town and stay here in Whakatane at least one night.

Approximately 20% of our customers are foreign visitors.

We work with Whakatane District Council i site staff who book customers through the i site and send them to us. We currently have to send all our customers to use the Z service station toilets prior to the rail tour. This arrangement is far from satisfactory. Firstly the distance from the railway station to the service station. Many of our customers are elderly.

Secondly the toilets at the service station are at capacity in terms of infrastructure, they are not coping with extra demand we place on them. Our business has grown considerably since opening in 2014.

At present we are relying completely on Z Service stations good will to provide toilets for our visiting customers. That situation is unsatisfactory and was only intended as being

temporary when we opened the business. The nearest public toilet is at the Awakeri events centre and that is not at all practicable for our use, it is to far away and difficult for visitors to locate and often not open when we would need it.

When our business opened inn 2014 we had discussions with District Councillor the late George Johnston and he expressed the need for a public toilet in Awakeri village but no progress was made at the time.

4. The coffee shop operates near by to us and they also have large numbers of customers who stop in the village for refreshments and use toilets. Along with of course, the shop and takeaways all of the businesses in the village have customers who require toilets.

5. Health risk.

Sadly, it is a regular occurrence that motorists /visitors who stop at the shops or our car park at the railway either cant be bothered to go to the Z service station toilet or they don't know its there, and simply use the car park and surrounding area to relieve themselves.

I and other business owners in the village are forced to remove human waste from the car park area, gardens and around the railway station its self. Toilet paper and human faeces have been found, for example near the entrance to the coffee shop on more than one occasion. Nappies are also regularly dumped in the area around the shops and railway station.

This obviously poses a serious health risk for myself and other business owners, as we are forced to dispose of it.

Given that our customers are mostly out of town visitors many from over seas, we are left to ensure no customers have to endure these unpleasant sights.

I submit there is an urgent need for a public toilet to be located in the Awakeri village shopping area.

Positioning of the toilet.

I believe land would be available for a toilet at the northern end of the Awakeri shops car park.

There is ample land area there, that is the property of Kiwi Rail. I am confident a site would be able to be arranged with Kiwi Rail.

"With Three Waters back on our books, we can only factor minimal maintenance and compliance costs into the budget for the next 10 years due to funding limitations. This means that important upgrades will not be able to happen unless something significant changes" We could easily use the extra \$95 million to upgrade our 3 waters infrastructure rather than going for the more lucrative options 1 and 2. Option 3 is a good approach considering the current situation. I support the little theater and the rugby grandstand getting an even consideration to improvements. However, why is it Option 3 not covered across the same years as the other 2 options? Could it not be spread out through 2027-2031 like the other options? Or at least an extension into 2029 as it's likely to be delayed. Work on one of the bullet points each year. Spread the cost a bit more evenly. I am also unsure why there is such a gap in cost between the first 2 options and Option 3. Is there no other middle ground of a say \$50 million upgrade? Why is it minimal or maximal? RUGBY GRANDSTAND Strengthening and adding a couple of pods for changing rooms for women and men should suffice. Then get some local artists to paint nice murals on them. It doesn't have to be an architecturally designed structure as we're there to watch the rugby not what we're sitting on. PLAYGROUND Let's not go overboard with contractors and plans for a new playground. Add to the one we've got with some more user friendly options next to the current set up. We don't need to spend thousands when our tamariki will enjoy whatever is on hand, provided it is accessible and safe to all. A minimalist approach would be valued. CAR PARKING We should be tentative around increasing car parking. It is one of the least utilized parts of the 'HUB' and there are maybe a maximum of 5 weekends out of the whole year that I would consider it being used to capacity. Considering we have the benefit of free street parking, a flat and accessible town to walk in and areas of grass and berms that are utilized when needed, it would be a shame to concrete over more of our decreasing field spaces. These fields are also one of the best remaining sources of storm water control we have when faced with more intense rainfall events. The more field space there is then the more diverse our sports can also be. Why not incorporate a parking space into a building space to maximize usage? We could always run a free shuttle from the Hub or the strand on the busiest days of the year. It's really not far. OTHER EXTRA POINTS What are "other' required improvements? If they were that important then I'm sure they would have been specified. Is there no option to get external funding through the development phase and not just in the construction phase of 2 years? Has there been any consideration to expand the Whakatane squash club facilities into a bigger inside court space for other sports too? The park area at Warren park could also be more utilized for more sports too. Could we plan the HUB (if the more expensive options went ahead) to be spread across 20 years? Unless there is a significant increase in external funding. We should reconsider how integral the war memorial hall is for our emergency response systems. For the likes of severe flooding or a Tsunami we may need to also look at other options on higher ground etc. It appears as though the council has already decided what option they prefer. I just hope it is not overdone

and that our oldest mature trees in the hub get the same consideration as our sports players before any changes are made.
