


Land Rates Arrears 2023/24

The 2023/24 year started with an overall land arrears balance (inclusive of penalties) of \$7,493,835 and it ended with a balance of \$8,205,263. Indicating an overall increase of \$711,428, a 9.49% increase from the end of the 2022/23 year.



The penalty balance applied is made up of:

- \$200,413 of P1 penalties 10% applied quarterly to overdue invoice balance from 2023/24
- \$574,133 of P2 penalties 10% applied annually to unpaid balance remaining from year ending 2022/23 at time of application

This compares to \$156,573 on P1 (28% increase) and \$571,982 on P2 (0.38% increase) from the 2022/23 year.



Rates Arrears

The collection rate (on newly invoiced balance) averaged 96.05% across the year, showing a decrease of 0.53% from the 2022/23 year (average of 96.58%).

Of the \$59,473,388 invoiced for the 2023/24 year, \$57,567,400 was collected giving an overall collection rate of 96.8% on newly invoiced accounts This shows a decrease of 0.43% from 2022/23 year (overall collection rate of 97.23%)








Water Rates Arrears 2023/24

The 2023/24 year started with an overall Water arrears balance (inclusive of penalties) of \$1,283,925 and it ended with a balance of \$1,404,495. Indicating an overall increase of \$120,570, a 9.4% increase from the end of the 2022/23 year.



The invoice balance of \$1,272,355 is made up of:

- \$286,449 overdue invoice balance for 2023/24 year a decrease of 10.2% from previous year (\$318,827 2022/23)
- \$985,906 overdue invoice balance remaining from prior years an increase of 16.9% (\$843,680 remaining prior years)

The penalty balance of \$132,139 is made up of:

- \$50,177 of 10% penalties on overdue invoice balance for 2023/24 year an increase of 1.36% from previous year (\$49,503 2022/23)
- \$81,962 balance from 10% penalties on overdue invoice balance remaining from prior years an increase of 14% (\$71,915 remaining prior years)





Land Rates Arrears by location at 30 June 2024







Water Rates Arrears by Location at 30 June 2024






Land Rates Invoiced and Collected 2024






Water Rates Invoiced and Collected 2024




Rates Rebates, Email opt-ins and Direct Debits

Rates Rebates Processed 2021-2024




Direct Debits Comparison 2023-2024



Note - Water billing direct debits are deducted due date only




Statute Barred Write Offs




Statute barred debt is six year old debt unable to be recovered through the courts. Statute barred rates for 2018 processed on the 5 October 2023 includes BOPRC
