- The prevalent issue of alcohol-related harm as a result of alcohol misuse, citing its significant contribution to injuries.
- That by promoting reduced outlet density and operating hours to limit access to alcohol it would aim to reduce alcohol addiction, support individuals in need, and protect community health.
- The need for collaborative efforts to reduce alcohol misuse in our communities, recognising its generational impact.
- It was proposed that, to minimize alcohol-related harm and to safeguard our communities, focus on strategies within our Local Alcohol Policy needed to be considered.
