3 CONFLICTS OF INTEREST

CCS panel Member Whale noted a conflict of interest as being a member of the Edgcumbe Choir and Arts Whakatāne with its involvement in the Light Up Whakatāne festival.

4 PUBLIC FORUM

4.1 S Orme

S Orme gave an overview of their project 'Kaumatua Kaupapa' which involved capturing photographic portraits and personal experiences to preserve cultural aspects. The initiative entailed collaborating with and conducting research on elderly Maori community members. Some experiences include domestic violence, incarceration and overcoming the challenge of speaking Te Reo on the marae.

4.2 Eastern Bay Villages – C Carpenter

C Carpenter provided the Committee with his own experience being involved with Eastern Bay Villages. He has seen noticeable improvements with participation of elderly community members. Their project 'The Art of Ageing' also has a focus in a gap of health research.

4.3 Edgecumbe Choir – S Baresic and M Vanderboom

The Edgcumbe Choir planned to stage Haydn's creation to a full house, with rehearsals commencing in June. The project involved 35 active members and received outstanding reviews for previous performances from the community, particularly noting the strong youth involvement. The allocated funding will assist in managing project costs and keeping ticket prices affordable for attendees.

4.4 Flame Entertainment - M Begley

Flame Entertainment, based in Queenstown, specializes in festival events, offering a unique focus on engagement and interactive experiences. Their productions cater to a wide range of ages, making them accessible and enjoyable for diverse audiences. They will also perform 'The Faeries' at the Whakatāne Light Up festival.

4.5 Stage Door Productions Charitable Trust – C House

'Little Women' would feature an all-youth performance, supported by an off-stage crew of similar age. The production would feature sound and lighting equipment operated entirely by youth participants. The team focused on securing sponsorship and implementing cost-effective marketing strategies. An audience of approximately 1,000 people was anticipated for the performances.

4.6 T Blair & A Clyde

The third edition of the event 'Nature Dance Floor' focused on creating interactive light-up installations that captured the interest of many youth attendees last year. They would like to carry out the same project with enhancements for this year's event. This year, efforts were made to ensure wheelchair accessibility.

4.7 Te Waimana Kaaku – M Edwardson

The project aimed to preserve Tuhoe's cultural practices through waiata, haka, and other traditional forms. Drawing from historical roots, the initiative would share generational knowledge within a wide age range.

4.8 Theatre Whakatāne - A Smith

The audition process for the full cast of 'Oliver' has been completed, with 36 individuals selected. Rehearsals will span two weeks, culminating in 4-5 shows per week during the production run. Funding will go toward the directors' fee of \$12,000. An audience of approximately 2,000 is anticipated.

4.9 Thornton School – S Brenner

The 'Addams Family' production performed by Thornton School features a diverse cast of youth performers, with babies often stealing the spotlight. To enhance the performance, scaffolding will be utilised to elevate certain cast members who wouldn't typically be raised during the show.

4.10 T Akehurst

T Akehurst's project for Light Up Whakatane 2024 would feature a gallery of sculptures. A substantial project that utilised primarily recycled materials, although some additional recycled materials would

need to be purchased. The project would be designed for potential reuse and could be considered for installation at various locations within the town.
