### **6.2 Whakatāne District Climate Change Risk Assessment**

Refer to page 13 of the agenda and pages 13 a-b of the tabled items.

The Strategic Projects Manager explained how the Council Climate Change Strategy commenced four years ago and initially had a focus on internal results, and then it extended out to the community. He reported that the purpose of the Climate Change Risk Assessment project was to build an understanding of the risks that climate change brought to the Whakatāne District, and that those risks would inform adaptation responses that would grow communities' capabilities to be more resilient to climate-related impacts.

The project was in stage one (of five). Resulting from a workshop held with sector experts, where potential climate change risk locations had been mapped. Feedback from, the communities was required to identify, and prioritise, any further risks. Staff would liaise with the Board Chairperson on engagement opportunities.

The importance of continual updates to the communities was expressed, noting also that the programme of work would continue into the next triennium.

It was requested that the map of identified risks include a legend, so the risk type was known.
