6 PUBLIC PARTICIPATION

6.1 Rod Meharry

Refer to pages 6.1a-b of the tabled items.

Mr Meharry requested the Council to accurately differentiate between rough sleepers and tourists and he urged that the bylaws be amended to reflect this distinction appropriately. Additionally, he proposed that the Council investigate the possibility of creating 'Tect Parks,' similar to those managed by the Bay of Plenty Regional Council, as a potential solution.

6.2 Christine Larsen

Ms Larsen, a full-time motor home resident, expressed her concerns that the current bylaw did not adequately address or consider the needs of genuine tourists and visitors. She highlighted full-time motor home residents often stayed in one location for extended periods and adequate provisions should be reflected in the bylaw.

6.3 Stewart Stephen and Jodie Craig

The submitters noted that Maraetōtara Reserve was an area commonly utilised by freedom campers. Concerns were raised about the existing bylaw, which was seen as obstructing parts of the reserve. The suggestion was made that the Council consider converting this area strictly for parking use.

Numerous instances regarding community safety concerns were cited. Observations from the morning prior to this meeting indicated 10 vehicles had stayed overnight, with only 2 being self-contained, and it was emphasised that the area was not being monitored. It was also mentioned that the Council has been contacted multiple times to enforce regulations in the area.

6.4 Helen Morris - Edgecumbe Development and Improvement Team (EDIT)

Refer to page 6.4a of the tabled items.

The E.D.I.T. group expressed dissatisfaction allowing freedom camping at the Edgecumbe Domain carpark. It was highlighted that the group had been working to improve various areas of Edgecumbe. The carpark was noted as a space frequently used by community members, and concerns were raised about the dump station's location, which posed risks to children unaware of potential dangers. Additionally, concerns were voiced about littering from non-compliant freedom campers. The E.D.I.T. group suggested redirecting camping activities to McAlister Street as a potential solution.

6.5 Robert Morris

Mr Morris expressed concerns regarding freedom campers in Edgecumbe and identified the current dump station as a potential risk. He recommended decommissioning the dump station to mitigate these risks. Additionally, he suggested that Thornton Hall Road could serve as a potential location for public conveniences, which would better align with the community's needs.

7 REPORTS

7.1 Public Places and Freedom Camping Bylaw

Refer to pages 15-179 of the agenda.

It was highlighted that staff had received a total of 81 submissions and that staff were looking for direction on section 4.6:

- 1. The proposal to prohibit the lighting of fires in a public place (excluding cultural fires).
- 2. The proposal to increase in night stays in restricted areas from two to three nights within a fourweek period.
- 3. The proposal to extend prohibited areas at West End, Ocean Road, and Port Ohope.
- 4. The proposal to prohibit freedom camping at Rex Morpeth Park to allow Council to use the Freedom Camping Act for enforcement.
- 5. The proposal to allow self-contained vehicles to freedom camp at Edgecumbe Domain.

Discussion ensued around several key points concerning freedom camping and associated matters. There was general support for items 1, 2, 3, and 4. However, item 5, which specifically addressed freedom camping, did not receive support.

Council suggested there should be further investigation into the Kiwi Camp Facility and suggested taking action to prohibit freedom camping on Maraetōtara Reserve before the next meeting. It was also proposed that staff assess the suitability of the current camping areas and explore potential alternative locations for camping.

Council emphasised the need for clear definition of groups on items 1, 2, and 3, particularly regarding which groups would be exempt from the regulations. Item 4, concerning Rex Morpeth Park, was identified as difficult to enforce under current conditions.

There was opposition to the inclusion of the use of coal in item 1, with a suggestion to investigate the use of fires on the beach. It was further suggested that CCTV cameras be installed at the Maraetōtara Reserve to enhance safety measures. The location of the dump station in Edgecumbe was recommended for review.

Staff highlighted the road naming had been a challenging decision and that it had been presented to the Council three times in total. During discussions it was raised that Acacia Avenue did not reflect significant historical and cultural aspects. Additionally, it was noted that there was no applicable disadvantage for Waana Davis Place. Concerns were raised about the long timeframes for road naming.
